

Active Swindon Challenge 2021 - 2022 - Terms and Conditions

Terms and Conditions

1. The Promotion App and Website (www.swindontravelchoices.co.uk/activeswindonchallenge) is free and open to residents of the UK.
2. Only those people living and / or working in the Swindon Borough Council area, and recording trips within the borough boundaries, will be eligible to win the prize draws. Prizes can only be sent to a valid UK address unless otherwise stated.
3. The Promoters have the right to refuse entry to any Individual / Organisation / Group / Team.
4. The competition period will run from the dates stated on www.swindontravelchoices.co.uk/activeswindonchallenge
5. The website and app are available to use free of charge while it remains online and in the app stores. Only those individuals that join challenges and scan QR codes during the competition period will be eligible to win prizes in the Promotion.
6. No responsibility shall be assumed by the Promoters for any failure of hardware or software. Any late entries or incorrect data logged because of this shall not be considered eligible and the Promoters will not be liable.
7. Journeys logged and QR codes scanned via the Active Swindon Challenge App, will be eligible for inclusion.
8. Individuals and Organisations participate in the Active Swindon Challenge at their own risk. The Promoters will not be liable for any injury to persons or damage to property.
9. Winners will be chosen at random from all valid entries from registered players. Winners will be contacted via email. Information about the prizes available and the qualifying criteria can be found on the Promotion Website. All winners will be notified by email.
10. The ultimate decision regarding prize winners will be made by the Promoters. This decision is absolute and cannot be challenged.
11. Teams with fewer than 2 people will not be eligible for Team prizes, but can use the website and app, will be eligible to take part in the draws for individuals.

12. User names of winners of prizes may be publicised on the website, and in the app and via other promotions (e.g. press releases).
13. Alternative prizes cannot be requested, however, the Promoters may substitute prizes for something of an equal or greater value.
14. Prize winners may be asked to participate in publicity.
15. Players who cheat (i.e. intentionally record car trips as walk or cycle trips or register fake accounts) will be disqualified – their accounts will be removed. If a team is deemed to have cheated that team can also be removed from the game.
16. Participants under the age of 16, when using the app, must do so with parental permission.
17. Individuals may withdraw from the promotion at any time by request by emailing the Challenge Co-ordinator (challenge@swindontravelchoices.co.uk).
18. The competition is open to employees or agencies of Swindon Borough Council and partners, their family members and anyone else connected to the prize draw. Such persons will be eligible to play the game and to win prizes, however prize winners (including employees/spouse/children) will be required to donate prizes to a suitable nominated cause/person(s).
19. All data is held in accordance with the General Data Protection Regulation. Any data collected will be anonymised, analysed and used to evaluate the Promotion, as well as support any future funding bids.
