Site Introduction	This Travel Plan covers Phase One of the Catsbrain Farm development by Persimmon Homes, consisting of 120 residential units.
Local amenities	There are a number of facilities located in close proximity to the proposed development, most of which are situated in the neighbouring suburbs of Kingsdown and Stratton St Margaret: Convenience Store: 2.0km - The Co-operative Food, Ermin St; Post Office: 2.1km - Upper Stratton Post Office, 198 Beechcroft Rd; Supermarket: 2.0km - ALDI, 9 Hobley Dr; Supermarket: 4.0km - Sainsbury's, Oxford Road; Public House: 1.4km - The Rat Trap, Highworth Rd; Dentist - 3.7km: Pinetrees Community Centre, The Circle, Pinehurst; GP: 1.5km - Merchiston Surgery, Highworth Rd; Pharmacy: 1.5km - adjacent Merchiston Surgery, Highworth Rd; Primary School: 2.0km - St Catherine's Catholic Primary School, Davenwood; Primary School: 2.0km - Kingsdown School, Delamere Dr; Secondary School: 2.0km - Kingsdown School, Hyde Rd; Post 16 College: 5.6km - New College Swindon, Queen's Drive Campus, New College Dr; Nursery School: 1.9km - Sunrise Nursery, Kingsdown School, Hyde Road; Leisure Centre: 2.2km - Kingsdown Sports Centre, Hyde Rd;

Aims and Objectives

Aims & Object	ives of Travel Plan
Aim	The aim of this Travel Plan is to minimise the transportation impacts of the proposed development by seeking to restrain car usage, whilst simultaneously seeking to maximise the number of journeys made to and from the site by walking, cycling, and public transport.
Objectives	 reduce the level of vehicular traffic generated by the development to a lower level than would otherwise occur without the Travel Plan in place; reduce single occupancy car trips to and from the site; increase the proportion of trips made to / from the site by walking and cycling; promote healthy lifestyles and sustainable travel patterns; contribute to the reduction of CO2 emissions and reduce the environmental impacts of the development; and to ensure that all residents and site users are aware of the Travel Plan.

Transportation Links

Details of Walking Access to site	New footways will be provided along Kingsdown Road to the south of the site and along Highworth Road to the west of the site, with those on Kingsdown Road being separated from the road by a grass verge. New footpaths will also be provided along the northern and western boundary of the site connecting onto Highworth Road and Kingsdown Road. Footways will be provided along most roads within the development itself, with those not provided with footways featuring shared surfaces. Additional connections will be made through the centre of the development to Kingsdown Road and Highworth Road. Dropped kerbs are proposed on Highworth Road to the north of Vickers Roundabout (located adjacent to the development) to enable safe crossing towards South Marston Industrial Estate. The existing joint foot and cycleway that runs along the western side of Highworth Road as far as the northern end of the B&Q distribution centre approximately 120m to the south of Vickers Roundabout, will be extended right up to the roundabout where dropped kerbs will be fitted across Kingsdown Road to facilitate easy walking and cycling access into the development. The joint foot and cycleway (which initially runs along the eastern side of Highworth Road), runs towards Stratton St Margaret, where a number of local amenities are situated.
Details of Cycling access to site	A Joint foot and cycleway runs from Vickers Roundabout located at the south eastern corner of the development into Stratton St Margaret. This currently runs on the eastern side of the road for a short stretch, before transferring over to the western side approximately 120m south of the roundabout. This will be altered as a result of the proposed development, with the existing foot and cycleway extended on the western side as far as Kingsdown Road to provide access into the development. The foot and cycleway provide a segregated cycle route along Highworth Road as far as Stratton St Margaret, where a recommended on-road cycle road commences to the southern end of Grange Drive. A segregated cycle route re-commences from Greenbridge retail park (situated a short distance from Grange Drive), providing an off-road cycle route as far as the edge of Swindon town centre.
Details of Bus access to site	The nearest bus stops to the development are situated on Stirling Road (South Marston Park Bus Stops), located a maximum of 240m from Vickers Roundabout (adjacent to the development). Bus service 7 operated by Stagecoach, calls at these stops and operates between Swindon Bus Station and Highworth, also serving Stratton St Margaret (for BMW and the Industrial Estate), Greenbridge Retail Park and Ocotal Way (for the Tesco Supermarket). Service 7 normally operates every 10-15 minutes during the daytime on Monday to Saturday. During early mornings (before 6am on weekdays and 8am on Saturdays) and early evenings (from 6:30pm on weekdays and 5pm on weekends until 7.30pm) there is bus every 20-30 minutes. After 7.30pm until 10.30pm there is bus every hour. The first bus on a weekday is at 5am and on a weekend is 5.50am. The last bus Monday - Saturday is at 10.30pm. On Sundays and during Public Holidays there is a bus service every 30 minutes between 8.30am and 6.30pm, with no late evening or early morning service. The service is currently operating a reduced service and may be subject to change once restrictions on COVID-19 have eased.
Walking Route to closest bus stop	As part of the development proposals, new footways will be created along the northern side of Kingsdown Road and western side of Highworth Road, adjacent to the development. Dropped kerbs will be introduced on Highworth Road, at the northern approach to Vickers Roundabout to enable pedestrians to cross over safely to Stirling Road. Pedestrians wishing to catch a bus towards Swindon should cross Stirling Road to the west the Roundabout junction with Hunts Rise, whilst those heading towards Highworth, should cross Hunts Rise.
Details of Rail access to site	Swindon is the nearest railway station, located close to the town centre and approximately 5.7km to the proposed development. Bus service 7 operates to Swindon Bus Station, which is only a short walking distance from the railway station. Cycling to the station takes just under 30 minutes.

Transportation Links	
	This is a summary of the services operating from Swindon station - the frequency applies during the daytime, seven days a week: Five trains per hour to London Paddington via Reading. Some trains also serve Didcot Parkway; Two trains per hour to Bristol Temple Meads via Chippenham and Bath Spa. Some peak hour services continue to Weston-Super-Mare; Two trains per hour to Cardiff Central via Bristol Parkway and Newport. One train per hour continues to Swansea via Bridgend, Port Talbot Parkway and Neath, and occasional journeys extend beyond this to Carmarthen; One train per hour to Cheltenham Spa via Kemble, Stroud, Stonehouse and Gloucester; and Between seven and eight trains per day to Westbury via Chippenham, Melksham and Trowbridge.
Walking route to closest train station	The train station is 5.7km to the site. This can be walked in just over an hour using footways along Kingsdown Road, Beechcroft Road, Cricklade Road and Station Road. The footways are continuous and lit.
Details of Road Access to site	A priority junction off Kingsdown Road, to the west of Vickers Roundabout will be created to serve the new development, with roads circulating around the development feeding onto this.

Public Transport Season Tickets	To encourage more public transport trips within the development, first time buyers within the development will be offered a free Flexi 5 bus pass, which can be used on all bus services operated by Stagecoach Swindon within the Swindon Borough Area.
	Additionally, a £20 GWR rail voucher is available to each household.
Sustainable Travel Voucher Scheme	A 'borrow a bike' scheme is proposed, providing residents with free use of a bicycle for up to six weeks. Once this has ended, residents will be provided with a bike discount to encourage them to make a purchase of a bicycle.
Car sharing incentives	Residents who take part in Travel Plan surveys will be asked if they would like further information on car sharing, as well as help in finding car share partners within the development. If there is interest the Travel Plan Coordinator will speak to residents and arrange for car sharing to be organised.

Information provided to staff/ visitors (e.g. information board)	Sustainable travel information will be provided to residents via the Travel Information Pack issued to each household. A noticeboard will also be located in a prominent position within the development (possibly adjacent to the retail area).
